Proposal from the Lakenon Baptist Church, Church Council to establish Hope On The Road Ministries as its own entity, and separate it from Lakenon Baptist Church.

1. The name of the Mobile ministry shall be Hope On The Road Ministries (HOTR), the name that it has been operating under and that is registered with the Secretary of State of Texas.
2. LBC authorizes Pastor Stephen D. Burnett, and the Church Council to take necessary steps to establish HOTR as its own entity, separating it from LBC.
3. LBC will authorize the formation of an initial 3-member Board of Directors/Officers that shall consist of the following (3 is the number required by the State of Texas to begin)
 - a. President – Pastor Stephen D. Burnett
 - b. Vice President – Russel Cudmore
 - c. Treasurer – Mary Beth Burnett
4. LBC authorizes Treasurer Mary Beth Burnett to establish financial accounts under the name Hope On The Road Ministries.
 - a. The following will be signers on these accounts
 - i. Mary Beth Burnett – Treasurer
 - ii. Stephen D. Burnett – Pastor/President
 - iii. Russel Cudmore – Vice President
5. LBC shall give to HOTR all monies that it currently has, and all monies that it shall obtain during the process of separation, with the exceptions listed below.
 - a. Any monies designated for building repairs, that are currently in the savings account
 - b. Any monies given specifically to repair of the building during this process.
 - c. HOTR will continue to pay basic bills until July 2025 or until such time as a new church has taken over the property and become financially able to cover the bills, but not to go beyond July 2025.
6. LBC shall also give to HOTR the Camper Texas License Plate #B64 7639 that was donated to LBC for the Mobile Ministry.
7. LBC shall give to HOTR all items currently being used by HOTR, all items purchased for HOTR, and any items necessary for conducting the ministry, including but not limited to the following:
 - a. Sound & Video Systems
 - b. Folding Chairs
 - c. Tables
